### **NOTICE INVITING TENDER**

- Sealed tenders affixing court fee stamps of Rs. 8.25 (Rupees Eight Point Two Five Paisa) only are invited from the Empaneled Contractors of BKWAC for execution of total 117 nos. of construction work under various Deptt. of Council with value of below Rs. 50.00 lakh (Rupees Fifty Lakh) for the year 2024-25 (Phase-2)<u>list of schemes enclosed</u> in the Tender Document at Annexure-A.
- Cost of Tender Document: Rs.1000/- (Rupees One Thousand) (non-refundable) only should be deposited through bank transfer/ net banking/ digital platforms such as Google Pay/ Phone Pay/ Paytm etc. in the *Indian Bank, Account No.7045488007, IFSC-IDIB000S700* in favour of the Principal Secretary, Bodo Kachari Welfare Autonomous Council, payable at Sanjari Nwgwr, Simen Chapori and requested to submit the deposit receipt to the concerned deptt.
- Tender documents can be obtained from the office of the Principal Secretary, Boro Kachari Welfare Autonomous Council, Bodoland Bhawan, Survey, Beltola, Ajanta Path, Ghy-28 and Sanjari Nwgwr, Simen Chapori, Dhemaji during office hours on all working days or may be download from the website of BKWAC <u>www.bkwac.in</u> w.e.f. 01/04/2025 to 21/04/2025.
- Earnest Money: 2% against work value (1% for ST/SC/OBC/MOBC) is to be deposited along with the tender documents in the form of Bank Draft in favour of the Principal Secretary, Bodo Kachari Welfare Autonomous Council, Sanjari Nwgwr, Simen Chapori, Dhemaji.
- ✤ Last Date and time for submission of tender: 1.00 pm on 21/04/2025.
- Separate bids are to be submitted for each of the schemes separately.
- Bidding document must be submitted in the designated tender box at Council Office, Bodoland Bhawan, Survey, Beltola, Ajanta Path, Ghy-28 or Sanjari Nwgwr, Simen Chapori, Dhemaji.

#### • <u>Eligibility of Contractor:</u>

- a. The Contractor must be registered with the Authority of BKWAC.
- b. The Contractor must be a resident of notified area of BKWAC.
- c. BKWAC reserves the right to debar any contractor, even if he or she is registered with BKWAC, from participating in a bid on grounds of failure in executing previous works, misconduct, involvement in criminal, anti-social or immoral works.
- d. Registered firms'/Suppliers'/ contractors of BKWAC notified area are only eligible to participate in the Tendering process.
- <u>Opening of Tender:</u> The Tenders will be opened at the Conference Hall, Bodo Kachari Welfare Autonomous Council, Bodoland Bhawan, Survey, Beltola, Ajanta Path, Ghy-28 at **02.30 pm** on **21/04/2025** and Sanjari Nwgwr, Simen Chapori, Dhemaji from **01.00 pm** on **22/04/2025**, respectively by the authorized officers in the presence of the intending bidders or their authorized agent/person who wish to be present on the specified date and time. If the office of the Principal Secretary, Boro Kachari Welfare Autonomous Council, happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue. The date & time of opening of the Financial Bid will be intimated to the bidders who have qualified during evaluation of technical bids.
- **Evaluation of Price Bid**: The Tender Committee duly constituted by BKWAC Authority will evaluate both the technical and price bid and recommend successful bidder for award of works.
- <u>Validity</u>: The Bid shall have to remain valid for minimum 15 days and an undertaking must be submitted to this effect.
- The Contractor shall have to complete the work within the stipulated completion period as stated in the Tender Document. The completion period will be counted from the date of issue of work order.
- No advance payment shall be made against any work. The Boro Kachari Welfare Autonomous Council reserves the right to accept or reject any tender or annul the tendering process at any time, without thereby

incurring any liability to the affected party or any obligations to inform anyone of the grounds for the Council's action.

- Both, the technical bid and the price bid(s) should be sealed in one envelope addressed to the Principal Secretary, Boro Kachari Welfare Autonomous Council, Bodoland Bhawan, Survey Beltola, Ajanta Path, Ghy-28 or Sanjari Nwgwr, Simen Chapori, Dhemaji, Assam and the name of the scheme tendered should be clearly written and underlined on top of the envelope.
- The tender shall be typed or written in indelible ink and shall be signed by the bidder or a person duly authorized by him or her.
- The tender forms should be filled up completely and prices quoted clearly in figure and words against the scheme tendered for.
- <u>Amendment of Tender Documents</u>: BKWAC Authority reserves the right to make any amendment to the Tender Document before the deadline for submission of bids by issuing corrigendum/addendum. Any corrigendum/addendum thus issued shall be part of the bidding documents after hanging the same in the office Notice Board.
- <u>Extension of deadline</u>: BKWAC Authority reserves the right to extend, as necessary, the deadline for submission of bids.
- **Language:** The bid of the bidder, as well as all documents attached to bid by the bidder and all correspondences relating to the bid exchanged by the Bidder shall be written in English language.
- <u>Documents to be submitted along with the tender:</u>
  - a. Signed statement mentioning the legal status, place of registration and principal place of business of the Contractor complete address of the registered office and address for correspondences with Phone number/ Fax number and E-mail ID.
  - b. PAN Card.
  - c. GST Registration.
  - d. Financially capability/ sound certificate from competent authority.
  - e. Experience certificate if any.
  - f. Trade License issued by the Boro Kachari Welfare Autonomous Council.
  - g. Contractor Registration Certificate of BKWAC.
  - h. Caste Certificate.
  - i. Labor License.
  - j. Contractor Registration Certificate (Line department if any).
  - k. A copy of passport size photograph of the signatory of the bid.
- <u>Payments:</u>
  - Schemes within the Rs 5.00 to Rs.10.00 Lakh, bills will be prepared only after at the least 80% and for 10.00 Lakh above bills will be prepared only after at the least 50% completion of the work.
    BKWAC authority will make payment only after satisfying itself about actual execution of work.
  - b. Final bill will be paid only after receipt of satisfactory reports of followings:
    - 1. Third parties' verification report.
    - 2. Verification report of entrusted IC EMs of district/ constituency, BKWAC
    - 3. Site verification reports by Council EM's or authorized persons.
  - c. Against the work value of 8% shall have deducted from final bill as security money. The amount will release after completion all orders & settlement of payment for which this tender has been invited.
- <u>**Taxes and Duties:**</u> The contractor shall be entirely responsible for and bear all taxes GST and any other tax, royalty, license fees, permits, etc., incurred during the execution of the work and submit clearance certificate to the BKWAC authority.
- BKWAC will not deduct such taxes GST and any other tax, forest royalty, license fees, permits, etc.; but at the same time will not release the final bill unless proof of payment of such taxes GST and any other tax, forest royalty, license fees, permits, etc. to the concerned Govt. authority is submitted to BKWAC authority. BKWAC will scrutinize such documents and shall release final payment only after satisfying itself.
